This is a plan that describes how Lamar County Middle School (LCMS) will provide opportunities to improve parent engagement to support student learning. LCMS values the contributions and involvement of parents in order to establish an equal partnership for the common goal of improving student achievement. How is it developed? Lamar County Middle School welcomes parent input and comments at any time regarding the parental involvement plan. How will you receive timely information? Information regarding up to date information regarding all Title 1 programs will be posted on our website, announced in an automated phone call, sent home in weekly flyers, and on a weekly email if requested.

LCMS will ensure:

- That parents play an integral role in assisting with their child's learning;
- That parents are encouraged to be actively involved in their child's education at school;
- That parents are full partners in their child's education and are included, as appropriate, in decision-making opportunities and on advisory committees to assist in the education of their child;
- All parents will be invited to develop, review, and improve the parent involvement policy annually;
- That a parent may contact the school staff, school counselor, or administrative staff to access teachers for academic information and updates regarding their child.
- That all LCMS staff responds to parents' concerns and requests in a timely manner reflective of the method in which it was received.

What are Title 1 Compacts?

As a part of this plan, LCMS and our families will develop a school - parent compact, which is an agreement that parents, teachers, and students will develop together that explains how parents and teachers will work together to make sure all of our students reach grade level standards. The compacts will be reviewed and updated on an annual basis using feedback from parents, students, and teachers in the spring of each year for planning purposes. The school - parent compacts are kept with each child's homeroom teacher if parents need a copy.

How can you as a parent stay involved and know what is going on?

- ✓ You can access all school information on the LCMS school website at www.lamar.k12.ga.us.
- ✓ You can also be added to a weekly email that comes out every Sunday afternoon with the week's events. Call the front office at 770-358-8652 to get your name added to this list.
- ✓ There are automated calls that go out daily if your child is absent, and additional calls that go out as needed to notify parents of special events and activities.
- ✓ All notification from the office comes home on Tuesday's on bright yellow paper to identify this is an important document for parents to read.
- ✓ You can access the Parent Portal on a daily basis to review your child's grades, attendance, and cafeteria/media balances.

LCMS will...

- The faculty and staff will provide parents the opportunity for face to face parent teacher conferences, by phone, or by email where teachers will provide the necessary materials and activities for parents to work with their child and improve the child's academic achievement.
- Ensure that the parent involvement policy, information on all school and parent programs, meetings, and other activities are published and posted in both English and Spanish as needed or requested on the school website, distributed in hard copy to all students, and available in the school media center.
- Conduct staff development each quarter through faculty meetings on parent involvement practices and effective strategies for staff to communicate and build partnerships with parents.
- Provide and post on our school website a course catalog of academic offerings with course descriptions, academic assessments, and student proficiency levels.
- Communicate with all families and the community on a regular basis regarding school wide events and activities using automated phone messages, the school website, school system Facebook page, and weekly flyers.
- Ensure that all parents have the opportunity to provide feedback on the parent involvement policy through surveys, emails, and weekly hard copy response.
- Work with our parents to provide and develop relevant trainings and helpful presentations to educate our staff on the importance of parental involvement.
- Provide necessary materials for parents at conferences, meetings, and activities to help parents work with their child to improve their child's academic achievement.
- Collaborate with parents, community leaders and business groups to develop, discuss, revise and agree upon the school parental involvement policy on an annual basis.
- Offer content nights for parents to help them interact with the academic content of Math, Science, S. Studies and Science.
- Provide monthly "Coffee Talk" sessions for parents based on requested topics of interest. Transportation is provided if needed.
